Offer terms and conditions

2. These Offer terms and conditions ("**Offer Terms**") are in addition to the J&K Bank Conditions of Use of J&K Bank Credit and Debit Cards. In the event of any conflict between the Conditions of Use of Banks Debit or Credit Card Offer Terms, these Offer Terms will prevail, only for the purposes of this Offer.
3. All residents of India holding a valid and active credit and Debit card issued by the Bank (each a "**Card**") are eligible to avail the Offer (each a "**Cardholder**").
