## E-AUCTION

Whereas, the Authorized Officer of The Jammu & Kashmir Bank Ltd in exercise of powers conferred under SARFAESI Act, 2002 and Security Interest (Enforcement) Rules, 2002, issued a Demand Notice under section 13(2) of the Act on **04.01.2023** calling upon Mr. Ghulam Ahmad Wagay S/o Mohd Habib Wagay R/o Manigam Ganderbal, J&K (**Borrower cum Mortgagor**) and his **guarantors**, to pay its outstanding dues in the loan account/s aggregating to **Rs. 9,11,617.09/- (Rupees Nine Lakh Eleven Thousand Six Hundred Seventeen and paise Nine only )** together with future interest & other costs and charges **within a period of 60 days.**

## TERMS AND CONDITIONS

1) The E-Auction is being held on “**As is where is**”, “**As is what is**”, “**Whatever there is**” and “**No complaint**” basis. To the best of knowledge and information of the Authorized officer, there are no encumbrances on the properties, except specifically disclosed herein. However, the intending bidders should make their own independent enquiries regarding the encumbrances, title of property/ies put on auction and claims/rights/dues affecting the property, prior to submitting their bid. The Authorized Officer/Secured Creditor shall not be responsible in any way for any third party claims/rights/dues. The bidders shall satisfy themselves as to the description, condition or accuracy of the details regarding the property/ies given hereinabove.

2) It shall be the responsibility of the bidders to inspect and satisfy themselves about the asset and specification before submitting the bid. 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.

7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode before 4.00 PM on **07.10.2024** shall be eligible for participating in the e-auction. The e-auction of above properties would be conducted exactly on the scheduled date & time as mentioned above by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of amount mentioned under the column "Bid Increase Amount" against the Property.
