The Authorized Officer/Secured Creditor shall not be responsible in any way for any third party claims/rights/dues. The bidders shall satisfy themselves as to the description, condition or accuracy of the details regarding the property/ies given hereinabove.
- iii) It shall be the responsibility of the bidders to inspect and satisfy themselves about the asset and specification before submitting the bid.
