7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before 04:00 PM on **18-10-2023** shall be eligible for participating in the e-auction. The e-auction of above properties would be conducted exactly on **19-10-2023 between 01.00 P.M to 04.00 P.M** by way of inter-se bidding amongst the bidders.
