6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.

7) The interested bidders who may have submitted their EMD not below the 10% of reserve price through online mode/DD before **04.00 P.M. of 05.03.2024 shall be eligible for participating in the e-auction. The e-auction of above property/ies would be conducted exactly on 06.03.2024 from **01.00 P.M to 03.00 P.M** by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of Rs.5,000/- (Rupees Five Thousand Only).
