TERMS AND CONDITIONS IN RESPECT OF E-AUCTION/ SALE NOTICE DATED 13.05.2024 FOR SALE OF PROPERTY MORTGAGED TO THE JAMMU & KASHMIR BANK LTD BRANCH TP KULGAM IN CREDIT FACILITY/IES OF RIYAZ AHMAD ITOO

- 1) The Auction is being held on "As is where is, As is what is, Whatever there is and Without recourse basis". To the best of knowledge and information of the Authorized officer, there are no encumbrances on the properties, except specifically disclosed herein. However, the intending bidders should make their own independent enquiries regarding the encumbrances, title of property/ies put on auction and claims/rights/dues affecting the property, prior to submitting their bid.
