6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.

7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before **04.00 P.M.** of 10.12.2024 shall be eligible for participating in the e-auction. The e-auction of above property/ies would be conducted exactly on 11.12.2024 from **03.00 P.M to 04.00 P.M** by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of Rs.20,000/- (Rupees Twenty Thousand Only).
