- 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.
- 7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before **04.00 P.M. of 7.11.2024** shall be eligible for participating in the e-auction. The e-auction of above property/ies would be conducted exactly on **08.11.2024 from 11.00 AM to 01:00 P.M** by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of Rs.5,000/- (Rupees Five Thousand Only). In case bid is placed in the last 5 minutes of the closing time of the e-auction, the closing time will automatically get extended for **5 minutes** (subject to unlimited extensions of **05 minutes** each). The sale certificate shall be issued in the name of the successful bidder. No request for change of name in the sale certificate other than the person who submitted the bid / participated in the e-Auction will be entertained.
- 15) The bid once submitted by the bidder, cannot be cancelled/ withdrawn and the bidder shall be bound to buy the property at the final bid price.
