- 1) The Auction for sale of *Stocks, being pesticides/fertilizers* (Secured Asset) is being held on “**AS IS WHERE IS**” and “**AS IS WHAT IS BASIS**” and “**WHATSOEVER THERE IS BASIS** and **NO COMPLAINT BASIS**”. To the best of knowledge and information of the Authorized officer, there are no encumbrances on the said Secured Asset, except specifically disclosed herein. However, the intending bidders should make their own independent enquiries regarding the encumbrances, title of property/ies put on auction and claims/rights/dues affecting the property, prior to submitting their bid. The Authorized Officer/Secured Creditor shall not be responsible in any way for any third party claims/rights/dues. The bidders shall satisfy themselves as to the description, condition or accuracy of the details regarding the property/ies given hereinabove.
- 2) It shall be the responsibility of the bidders to inspect and satisfy themselves about the asset and specification before submitting the bid. - 4) After Registration by the bidders in the web-site, the intending purchaser/ bidder is required to get the copies of following documents uploaded in the web-portal before last date of submission of the bid(s) viz. i) Copy of the NEFT/RTGS/ challan. ii) Copy of PAN card/Aadhar Card iii) Proof of identification (KYC) viz. copy of Voter ID Card/Driving License/ Passport etc. iv) Copy of proof of address, v) Duly Filled up & Signed Copy of Annexure II & III attached to the Tender form, without which the bid is liable to be rejected.

- 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.
- 7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before **04.00 P.M. of 23-01-2025** shall be eligible for participating in the e-auction. The e-auction of above property/ies would be conducted exactly on **24.01.2025 from 01.00 P.M to 02.00 P.M** by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of Rs.10,000/- (Rupees Ten Thousand Only). In case bid is placed in the last 5 minutes of the closing time of the e-auction, the closing time will automatically get extended for **5 minutes** (subject to unlimited extensions of **05 minutes** each). - 14) The sale certificate shall be issued after receipt of entire sale consideration and confirmation of sale by secured creditor. The sale certificate shall be issued in the name of the successful bidder. No request for change of name in the sale certificate other than the person who submitted the bid / participated in the e-Auction will be entertained.
- 15) The bid once submitted by the bidder, cannot be cancelled/ withdrawn and the bidder shall be bound to buy the property at the final bid price. The failure on the part of bidder to comply with any of the terms and conditions of e-Auction, mentioned therein will result in forfeiture of the amount paid by the defaulting bidder.
- 16) Decision of the Authorised Officer regarding declaration of successful bidder shall be final and binding on all the bidders.
