To the best of knowledge and information of the Authorized officer, there are no encumbrances on the properties, except specifically disclosed herein. - 7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before 04:00 PM on **16.10.2023** shall be eligible for participating in the e-auction.
