TERMS AND CONDITIONS IN RESPECT OF AUCTION NOTICE DATED 18-09-2023 FOR SALE/AUCTION OF IN RESPECT OF TATA Dumper LPK 1618 CRE BS IV bearing Registration No.JK03H-7401 (Model 2019) (Secured Asset) hypothecated to Jammu and Kashmir Bank Branch Waltengoo Kulgam in loan account of Javid Ahmad Bhat Son of Mohammad Hussain Bhat Resident of Batingoo Kund Tehsil Devsar District Kulgam (Borrower).

1) The Auction/ sale of TATA Dumper LPK 1618 CRE BS IV bearing Registration No.JK03H-7401 (Model 2019) (Secured Asset) is being held on “AS IS WHERE IS” and “AS IS WHAT IS BASIS” and “WHATSOEVER THERE IS BASIS and NO COMPLAINT BASIS”. 6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.

7) The interested bidders who may have submitted their **EMD not below the 10% of reserve price** through online mode/DD before **04.00 P.M.** of 10-10-2023 shall be eligible for participating in the e-auction. The e-auction of above property/ies would be conducted exactly on 11-10-2023 from **01.00 P.M to 03.00 P.M** by way of inter-se bidding amongst the bidders. The bidders shall improve their offer in multiple of Rs.5,000/- (Rupees Five Thousand Only).
