**TERMS AND CONDITIONS IN RESPECT OF AUCTION NOTICE DATED 20.11.2023 FOR SALE/AUCTION OF IN RESPECT OF VEHICLE BEING Maruti Suzuki S-presso bearing registration no.JK03J-5074,Model 2019(Secured Asset) hypothecated to Jammu and Kashmir Bank Branch Dooru Anantnag.**

**6) Only buyers holding valid User ID/Password and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the online auction process.**
