The senior counsel appearing for Mr. Saifi argued before a Bench of Justices Siddharth Mridul and Rainish Bhatnagar that prejudice was being created by the Delhi police against him when not even a prima facie case was made out.

The court was told the whole FIR was set up on the "opinion of two-three men sitting in special cell office". The counsel claimed the 42year-old has not committed any violence but was himself a "victim of custodial violence".
