Coronavirus death toll rises to 1,770

Beijing, Il February

China reported 106 new deaths due to the new coronavirus on Monday, pushing the overall death toll to 1,770, as officials announced stringent measures such as closing non-essential public venues and traffice restrictions to control the epidemic in the worst-hit Hubel province.

The National Health Commission (NHC) said 2,048 new cases of the virus have been confirmed, taking the total number of COVID-19 infected cases to 70,548, the state-run Xinhua news agency reported.

Of the new deaths, 100 were from Hubel Province, three in Henan, and two in Guangdong.

Though 10,844 people had been discharged from hospitals after recovery, the commission said in its daily report that 7,264 people were still suspected to be infected.
