Subject: Payment of Dearness Allowance to State Government Pensioners/Family Pensioners - revised rate effective from 01.01.2019.

Reference: State Administrative Council decision No 66/7/2019 dated 28.02.2019.

In continuation to Government Order No. 390-F of 2018 dated 13-09-2018, it is hereby ordered that State Government Pensioners/Family Pensioners shall be allowed Dearness Allowance on Pension/ Family pension as under:-

		Date from which applicable
9% of Basic Pay	12% of Basic Pay	01.01.2019

- (i) The arrears on account of enhanced instalment @3% D.A w.e.f January, 2019, shall be paid in cash to the State Government Pensioners and family pensioners in the month of April, 2019, and shall form part of pension/family pension there onwards.
- (ii) The payment of Dearness Allowance involving a fraction of 50 paisa and above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored; and
- (iii) Other provisions governing the grant of Dearness Allowance on pension / family pension such as the regulation of Dearness Allowance during employment/ re-employment, where more than one

pension is drawn etc. and other provisions of the existing rules / orders (as are not in conflict with the provisions of this order), shall continue to remain in force.
